**Information according to the article 13 of the Decree Law 30/06/2003 n. 196
"Code of laws in the matter of protection of personal data"**

The Decree Law 196 dated 30/06/2003 (Code of laws in the matter of protection of personal data) covers the protection of people and other subjects as regards to treatment of personal data.

With data treatment the regulation means "any operation or series of operations, even if carried out without support of electronic instruments, concerning collection, entry, organization, keeping, consultation, processing, modification, selection, extraction, comparison, utilization, inter-connection, freezing, communication, circulation, cancellation and destruction of data, including those not entered into a data base".

The writer, as Holder of Data Treatment, with reference to the establishment and/or execution of contractual relations, informs that the data, qualified by law as personal data, supplied (even verbally) directly by you or collected by third parties (via Agents and Distributors being part of the commercial organization of our Company, Commercial Information Companies, registers, directories or public data bases, associations, other public subjects), basically relating to business or company name, address, VAT identification number, fiscal code, telephone and fax numbers, e-mail address as well as data relating to the economic and commercial activity such as bank details and data on the financial solvency, could be object of the treatment in respect of the regulation covered by the Decree Law 196/2003 mentioned above and in respect of the accuracy, lawfulness and privacy obligations.

We are not into possession of sensitive or judicial data of your company according to article 4 sub-paragraph 1 of the Decree Law n. 196/2003.

Therefore, according to the article 13 of the Decree Law 196/2003, we supply you following information:

- Your personal data are treated for following purposes:
 - a) Execution of laws related to civil, fiscal and accountancy regulations, european community regulations, etc..
 - b) Execution of instructions given by suitably legitimated authorities and by vigilance bodies
 - c) Execution of contracts signed with you and linked obligations.
 - d) Accountancy, financial, organizational and commercial management
 - e) Protection of contractual rights of the writer, even in case of contentious .

Your personal data are treated (also with informatic and telematic procedures) as strictly required by the execution of the contractual relations, in accordance with the laws able of guarantee the privacy, the safety, the accuracy, the updating and the pertinency of the same data in respect of the purposes declared.

- Supply of data for the purposes mentioned at points above relates strictly to the contractual relation and it is absolutely necessary to fulfil the provisions of the regulations. Your refusal to supply the necessary data will hinder the writer from starting same contractual relations.



- Without prejudice to the communications given in execution of the obligations covered by laws or European community regulations, the data could be divulged in Italy or abroad to following subjects and categories of subjects:
 - Other companies of the group
 - Public Corporation or Category Associations
 - Authorities or Public Institutes
 - Credit Institutes
 - Credit Recovery Societies
 - Informatics and Business Advice Companies
 - Commercial information Companies
 - Independent collaborators, Business-Management Consultants and Lawyers.
 - Companies operating in the transport field
 - Forwarding agents
- Such categories treat the data for the same purposes mentioned above as independent holders. A list with names of the subjects whom your data could be divulged to is available by the Holder of the Data Treatment.
- The data will not be divulged for statistic purposes, except in aggregated and anonymous form.
- Personal data will not be divulged, where this means they will not be disclosed to indefinite subjects in whatever way, neither by making them available nor consultable.
- Subjects having access to personal data in one's capacity of Person in Charge and /or Holder for the Treatment are:
 - Employees at the Management and Commercial services
 - Employees at the Purchase and Logistics services
 - Employees at the Accountancy, Financial and Control services
 - People responsible for the running and maintenance of the informatics systems
 - Collaborators duly authorized to treat such data in conformity with the instructions received and only for the above mentioned purposes.
- Data will be treated for the length of the contractual relation and soon after for fulfilment of all the obligations foreseen by law and for possible future commercial needs.
- With regard to the same data you can assert the rights covered by article 7 of the Decree Law n. 196/2003 within the limits and conditions foreseen by articles 8, 9 and 10 of the above mentioned Decree Law. In particular you can verify by our company the existence of your personal data and ask such data to be made available in intelligible form; you can also ask for the origin of the data, for the logic and purposes the treatment is based on and also ask for their cancellation, transformation in anonymous form, freezing of the data treated in breach of the law, updating, modification and integration. Furthermore, in presence of legitimate reasons, you can appeal against the treatment partially or in full. For the exercise of your right, as well as for obtaining more detailed information on the subjects or the categories of subjects whom the data are disclosed to, or on those persons who are in charge and/or responsible, you can address to the Holder of the treatment, as mentioned below.
